

## **TERMS AND CONDITIONS**

- The Megasave Big Business Bonanza (the "Competition") is organised by the OK Franchise Division of Shoprite Namibia (Pty) Ltd. (the "Promoter").
- 2. The Competition commences on 12 April 2022 and will close on 8 May 2022 at one minute past 12 a.m. (the "Competition Period").
- 3. A person that enters the Competition (the "Entrant") agrees to be bound by these rules which govern this Competition. The Promoter reserves the right to amend or supplement the rules governing this Competition at any time by publishing the amended or supplemented rules on its website or by displaying them in participating stores. The Entrant will be deemed to have accepted such amended or supplemented rules upon publication on the Promoter's website or in participating stores.
- 4. The Competition is only open to persons who are residents in Namibia.
- The Competition is restricted to Megasave stores in Namibia and excludes any and all other OK stores, affiliated stores, and Megasave stores in South Africa.

- 6. In order to participate in the Competition, Entrants must purchase any three participating products. Entrants must be over the age of 18 years old during the Competition Period. The Entrants' entries will be disqualified if the Entrants' purchase receipts do not include any of these participating products at the time of the Entrants' entries into the Competition.
- To enter the Competition, the Entrants must send the token number on their till slip via USSD code or SMS.
- 8. The Competition is not open to directors, members, partners, employees, agents of or consultants to the Promoter, its franchisees, subsidiaries, marketing and promotional agencies, any person who directly or indirectly controls or is controlled by the Promoter or any other person involved directly or indirectly with the organisation of this Competition. - 9. The Promoter may, at its discretion, disqualify incomplete or fraudulent entries or entries that do not comply with these rules. The Promoter may also disqualify an Entrant if the Promoter finds that the Entrant has attempted to manipulate the outcome of the Competition.

- 10. After the closing date of the Competition, the Promoter or its representative will conduct a draw on 11 May 2022 to determine the 21 winners of the Competition. The winners will be the Entrants of the first 21 valid entries drawn. Entrants who purchased any three participating products and entered via SMS or USSD will qualify for the 21 prizes.

- 11. The winners of the Competition, if any, will be announced after the draw. The Promoter will contact the winners using the contact details provided in their entry. The Promoter will not be liable for the winners failing to receive a prize if the winner provided incorrect contact details in his/her entry. If the Promoter cannot contact a winner after taking reasonable steps to do so, that winner will forfeit the prize and the Promoter may, in its sole discretion, choose to conduct another random draw for that particular prize.
